PROHIBITION OF REBATES

The following is copy of Section 41 of the Insurance Act, 1938.

(1) No person shall allow or offer to allow, directly or indirectly as an inducement to any person to take out or renew or continue an insurance in respect of any kind of risk relating to lives of property in India any rebate of the whole or part of the commission payable or any rebate of premium shown on the Policy nor shall any person taking our Policy or renewing or continuing a Policy accept any rebate except any such rebate as may be allowed in accordance with the published prospectus or table of the insurer.

(2) Any person making the default in complying with the provision of this Section shall be punishable with fine which may extend to Ten Lakhs rupees.
